Admission Criteria

Due to the limited capacity of the School-based SCC, priority of admission will be given to:

- 1) Students who are Singaporean and qualified for Financial Assistance Scheme (Gross income < \$\$2,500 or <\$625 per capita Income).
- 2) Students who are Singaporean with both full-time working parents and no access to alternative childcare arrangements.
- 3) Students who are Singaporean with both full-time working parents and has alternative childcare arrangements.
